"It is with profound regret and sadness that I have to announce that our jovial Treasurer, DAVID W. MORTIMER, passed away on Tuesday night, December 10th. at his home in Waterdown.

The cause was a sudden cardiac event, and his passing was instantaneous.

Thankfully, he could not have suffered any pain.

Dave and I really got to know each other during this past year while serving on the Executive Committee.

While I did not know a great deal about him, one thing I do know-----his passion in life was his love of doing things for others, be it through a service club, for friends, acquaintances, or for the members of the GHWG.

As our treasurer, he was meticulous, but, simply because DAVE MORTIMER was the kind of man he was, he always took on far more than he needed to. From updating the

membership list, making the membership cards, donating and operating the P.A. system, hiring the coffee urn, which also entailed washing it out before returning it and even making the coffee.

We will all miss him greatly, and we express our deepest sympathy to his widow Nancy, who was hospitalised for observation and is resting comfortably in St. Josephs hospital in Hamilton, at the time of writing.

I spent a number of hours with Dave on Tuesday, checking out a possible new venue, and then the part he really enjoyed, shopping for the snacks and savouries for tonight's get -- together.

Had I but known to have asked him on Tuesday, I am sure he would have said not to worry about him,----- to go ahead with tonight's meeting without him.

And probably, he would have added, in his jocular tone,

"now, make sure everyone signs in and remind them to put their name tags back in the box before leaving"

So, in spite of our shock and sadness, let's carry on, as Dave would have wished us to.

As Dave had willed his remains to scientific research, there will be no funeral or service.

When Nancy is much better, there will probably be a memorial service and the GHWG will be represented.

Vince Redmayne called me on the 9th., to apologize for missing the December 12th. meeting, because his cardiac surgery had been scheduled for Wednesday 11th. in Toronto. I wished him success and a speedy recovery from all of us in the GHWG.

I am very happy to report that I was able to talk to his wife on the day after his operation and learned that the surgery was a complete success and he had a comfortable night.

As his wife was leaving the ICU, Vince yelled out to her "don't forget to bring my woodturning magazine".

He's all heart and probably still over six feet tall. We can check when he gets back to the meetings.

You will recall the November newsletter asked for suggestions for an alternative venue for our meetings and also mentioned that I would attempt to procure a low cost lathe.

As there had been no suggestions I scouted around and inspected two places, which were not really suitable.

My third attempt hit the jackpot, with the City of Burlington Parks and Recreation Department.

Due to a cancellation, they were able to offer us the Central Arena Rec. Centre, at 519 Drury Lane, in Burlington.

It's capacity is 180 people and has excellent lighting, numerous power outlets, a P.A.

system, storage facilities, and a fully equipped kitchen, should we ever hold a Saturday seminaar, or hand's-on members workshop.

We really lucked in, our existing rent is about \$100-00 for four and a half hours, and overtime rates for a Saturday.

The new cost will be \$78-00 for four and a half hours, regular rates for a Saturday, and is available for the third Thursday of the month. There's more.....

The hall is also available on the first Thursday of the month, at a cost of \$61-00 for three and a half hours.

So, for \$139-00, or just \$39-00 per month more, all prices including tax, we could get it.

This allows us to expand on the GHWG's objectives to promote and educate on woodturning,

by holding a casual night expressly for new members, beginners, and members up to mid-intermediate skill levels.

The casual educational nights will hopefully be done by commitment from two or three of our upper- intermediate and advanced level members

The Department agreed to hold our application until Friday 13th., after the members have had a chance to vote on it.

The President introduced two motions, to a total of 34

members in good standing, as follows.....

1) The GHWG should accept the offer of the hall from the Parks and Recreation Dept., at Drury Lane, on a non - contractual basis. And --- procure the best lathe available, but restricting the cost to no more than 50% of the GHWG cash balance on hand, being a maximum total expense of about \$840-00.

The motion was seconded by George Wilbur.

2) The GHWG should consider an offer made to the President by Ashman Technical for a new (or demo) General 160-2, at a substantially reduced price of \$1219-00 plus tax, a total of \$1401-85, provided that-----

(a) no more than 50% of the GHWG cash balance on hand be allocated, about \$840-00, and,

(b) The balance be made up from members response to a request for early, or immediate membership renewals of \$35=00 each.

The shortfall being about \$562-00, requiring 16 renewals by say mid January.

The motion was adopted by simple majority.

I did a stethoscope type test on the motor and headstock bearings, which sounded great. It was in excellent condition and appearance, in spite of it being about 11 years old. The new baby can be visited in my garage,
